# **Position Summary**

The Construction Project Manager at River City Housing plays a critical strategic and administrative role in managing single-family and multi-family affordable housing projects. This position focuses on overseeing project budgets, timelines, and communications with stakeholders to ensure projects are successfully executed in alignment with RCH's mission of delivering high-quality, energy-efficient homes. The role is primarily office-based, providing oversight and coordination, while collaborating closely with contractors, vendors, internal teams, and community partners to support project goals and compliance.

## **Key Responsibilities**

## **Project Oversight & Administration**

- Lead the administrative and strategic management of multiple construction projects including single-family new builds, renovations, multi-family developments, and homeowner repairs.
- Oversee maintenance for a 12-unit, affordable apartment complex for seniors and manage renovation processes for the historic building.
- Develop, monitor, and manage project budgets ensuring adherence to financial guidelines and funding source requirements.
- Establish and track project timelines, proactively identifying risks and coordinating solutions to maintain schedule integrity.
- Manage contract negotiations, approvals, and vendor relations while ensuring compliance with organizational policies and funding agency requirements.
- Oversee procurement processes, resource allocation, and logistical planning to support construction phases.
- Coordinate with the President/CEO and Vice President to align project execution with organizational priorities and funding milestones.
- Conduct on-site visits to construction sites to monitor progress and perform quality control inspections,
- Review and approve project documentation including permits, licenses, progress reports, and draw requests.

#### Client and Stakeholder Communication

- Serve as the primary point of communication for contractors, vendors, and internal stakeholders regarding project status, challenges, and milestones.
- Prepare and deliver detailed progress reports, budget updates, and risk assessments to leadership.
- Address and resolve inquiries, concerns, and warranty issues with homeowners and ensure follow-through on post-construction support and education.

## **Compliance & Risk Management**

- Ensure all construction activities comply with federal, state, and local building codes, safety standards, and environmental regulations.
- Collaborate with health and safety officers and site inspectors to maintain safe work environments.
- Monitor project quality control measures and conduct periodic reviews to uphold RCH's standards for energy efficiency and durability.
- Implement risk management strategies by anticipating project challenges and initiating mitigation strategies.

### **Qualifications**

- Minimum 5 years of construction project management experience, preferably in affordable housing or nonprofit sectors.
- Proven expertise in budget management, contract negotiation, and project scheduling.
- Strong ability to lead cross-functional teams and manage multiple projects simultaneously.
- Excellent communication skills, with experience in stakeholder management and client relations.
- Proficiency in Microsoft Office Suite; familiarity with construction management software (e.g., BuilderTrend) is a plus.
- Knowledge of building codes, safety regulations, and sustainable construction practices.
- Ability to interpret architectural plans, technical documents, and financial reports.
- Valid driver's license and insurability required.
- Certifications such as MSD EPSC and EPA Lead RRP are advantageous.

## **Work Environment & Physical Requirements**

- Primarily office-based with periodic visits to construction sites to monitor progress and conduct inspections.
- Ability to work in varying environmental conditions including outdoor site visits.
- Must be able to perform physical activities such as walking, climbing, and inspecting construction areas as needed.
